Haywood County Board of Education & State of Tennessee Immunization Information

Dear Parent or Guardian,

Your child entering seventh grade in the fall, or any new student to Tennessee schools, **is required** to have all immunizations. All students must submit the required state immunization form on or before the first day of school. If a form is not submitted, your child will not be allowed to stay at school and will only be allowed to return upon the completion of the required immunizations. Your child may have had the necessary immunizations but we do not have a record of it. The information must be brought to the office at Haywood Middle School. Specific information for your child's grade can be found on the county website <http://haywoodschoools.com> under Coordinated School Health or at <http://health.state.tn.us/CEDS/required.htm>. or at the local health department. A sample of the new Certificate of Immunization form is included on the back of this letter. If you have any questions, call the school nurse at 772-9613 ext. 2360 or 2730.

Information needed:

New immunization form required by state (**this is the only approved form**)
Tetanus-diphtheria-pertussis booster ("T-dap")
Chickenpox (Varicella) –**2 doses** or credible history of disease

It is state law that all 7th grade students must show proof of having the immunizations listed below or an exemption status **must** be checked off by your child's regular medical provider. All students must submit the required state immunization form on or before the first day of school. If a form is not submitted, your child will not be allowed to stay at school and will only be allowed to return upon the completion of the required immunizations. Your child may have had the necessary immunizations but we do not have a record of it. The information must be brought to the office at Haywood Middle School.
